HCAHPS Survey Pain Composite Measure - Communication About Pain

In 2016, CMS created and tested several new items related to pain management for possible use in the HCAHPS survey in response to stakeholder concerns. On July 5, 2017, CMS published a report to the HCAHPS website that describes the statistical properties of new *Communication About Pain* composite measure proposed for use in the HCAHPS survey.

The report includes a background on the HCAHPS survey, the approach CMS took to conduct testing, the 2016 HCAHPS mode experiment sample design, results from the testing as well as a summary and conclusion of their findings. The results of their testing led to a change in the HCAHPS survey. CMS proposed to replace the three pain items currently on the HCAHPS Survey with two new items that focused on communication about pain, along with a screener item.

Moving forward, the new Pain Management composite measure will be labeled more simply "Communication About Pain."

Hospital Compare Preview Reports Available Through August 13

The Centers for Medicare and Medicaid Services (CMS) have made the October 2017 Hospital Compare Preview Reports available on QualityNet. The Preview Reports will be available until August 13, 2017. The Preview Reports are for participating Inpatient Quality Reporting (IQR), Outpatient Quality Reporting (OQR), and PPS-Exempt Cancer Hospital Reporting (PCHQR) hospitals and facilities.

Everyone is encouraged to access and download the reports early in the preview period in order to have time for a thorough review. You may access your Hospital Compare Preview Reports by logging into the QualityNet Secure Portal and selecting the report you wish to view.

CAHPS Hospice Proposed Rule: Public Reporting - Correction

Correction to June 2017 CAHPS Insider: The proposed public reporting date listed in the June release should have stated <u>summer of CY 2017.</u>

CMS has identified several proposals surrounding public reporting, which include:

- 1. Begin public reporting of all eight CAHPS Hospice measures in summer of CY 2017
- 2. Display scores based on eight rolling quarters of data
- 3. Initially use CAHPS Hospice Survey data collected between April 1, 2015 and March 31, 2017
- 4. Update the display of scores quarterly
- 5. Only display scores for hospices with 30 or more completed questionnaires during the reporting period

Like other CMS Compare websites, the Hospice Compare website will feature a quality rating system that gives each hospice a rating between one and five stars. The two percent payment reduction would be tied to successful submission of compliant survey results, sometimes known as "pay for reporting" rather than performance on patient experience metrics, known as "pay for performance."

CMS Proposes to Postpone OAS CAHPS Mandate

In the Proposed Rule for CY 2018, published on July 20, 2017, CMS proposed to delay the date of a national mandate for OAS CAHPS until further rulemaking. A national mandate is currently set to begin with 2018 data collection. Once posted, the Proposed Rule will be open for public comment with a final decision regarding a mandate coming later this year in the Final Rule. The OAS CAHPS survey remains the national standard of measurement for hospital outpatient departments and ambulatory surgery centers.

If you are currently in the process of transitioning or are planning a future transition to the OAS CAHPS survey, this remains NRC Health's recommendation. NRC Health will continue to monitor this topic and keep you updated with regard to a mandate final decision for OAS CAHPS.

CAHPS for MIPS Survey Vendor Training

NRC Health has been approved as a CMS CAHPS for MIPS Survey vendor. CAHPS for MIPS is similar to and will replace CAHPS for PQRS. The survey is voluntary, and any group practice is welcome to participate. Although CAHPS for MIPS is not mandatory, it is highly incentivized.

NRC Health recently completed the first round of survey vendor training for CAHPS for MIPS delivered live by CMS. Members of the NRC Health team will also attend additional CAHPS for MIPS training on November 1, 2017. If you have questions regarding CAHPS for MIPS, please reach out to your Account Manager.

Determining Clinicians' MIPS Participation Status

Do you have clinicians who are unsure of their participation status in the Merit-based Incentive Payment System (MIPS)? Clinicians can now use an interactive tool on the <u>CMS Quality Payment Program website</u> to determine if they should participate in 2017.

Participation Criteria

Clinicians should participate in MIPS in 2017 if they:

- → Bill Medicare Part B more than \$30,000 a year AND
- → See more than 100 Medicare patients a year

Clinicians must also be:

- → Physicians OR
- → Physician assistants **OR**
- → Nurse practitioners **OR**
- → Clinical nurse specialists OR
- → Certified nurse practitioners

If a clinician is new to Medicare in 2017, they are not required to participate in MIPS. They may also be exempt if they qualify for one of the special rules for certain types of clinicians, or are participating in an Advanced Alternative Payment Model (APM).

MIPS Participation Status Letter

Practices should have received a letter in the month of May from the Medicare Administrative Contractor that processes Medicare Part B claims. This letter will tell the participation status of each MIPS clinician associated with the Taxpayer Identification Number or TIN in the practice.
