

Scheduled for April 26 is an upcoming release with a couple new features:



- Filter Labels Added to Real-time Site designed to let users see what the filter controls, even when there are multiple values selected.
- Hover Over with Active Parameters added to allow users to quickly see what parameters they have included in a report.
- Subscription to CSV Export for Feedback Report and Score Summary Report
