Hospital Compare Preview Data - NOW AVAILABLE

Hospital Compare Preview Data is now available. Hospitals have until March 9, 2019 to preview data that will be publicly reported on *Hospital Compare* this spring.

How do you access your preview data?

You can access your Hospital Compare Preview data by:

- 1. Navigating to the QualityNet website.
- 2. Selecting **Login** under the **Log in to** *QualityNet Secure Portal* header.
- 3. Selecting HQR Next Generation from the Choose Your *QualityNet* Destination dashboard.
- 4. Entering your *QualityNet* User ID, Password, and Security Code. Then, selecting **Submit**.
- 5. Reading the Terms and Conditions statement and selecting **I Accept** to continue.
- 6. Selecting the **Public Reporting Card (PR)** on the card layout on the landing page.
- 7. Previewing your data after the page automatically refreshes.

You can export the data displayed by selecting **Export Data** in the measure table. The exported measure data will be in PDF format for a user-friendly printed report.

Hospital Compare Updates - NOW AVAILABLE

On February 28, 2019, CMS will update data on the Hospital Compare website and on data.medicare.gov.

Data Updates

CMS has updated data for the following measure sets on Hospital Compare:

- Timely and effective care
- Hospital Consumer Assessment of Healthcare Providers and Systems (HCAHPS) Survey

- Healthcare-associated infections
- Rate of unplanned hospital visits after an outpatient colonoscopy (OP-32)

In addition, CMS is updating the Overall Hospital Star Rating. CMS updated the methodology to address stakeholder concerns following the July 2018 preview (for more information, see the <u>Star Ratings Methodology Update</u>).

Hospital payment measures for six common types of clinical episodes (i.e., three conditions and three procedures) are now available in the downloadable databases on <u>data.medicare.gov</u>.

Beginning with the February update, CMS will no longer report data on the following measures:

- Participation in a Systematic Clinical Database Registry for Nursing Sensitive Care (SM-3)
- Participation in a Systematic Clinical Database Registry for General Surgery (SM-4)

Data on measures of timely and effective care and patient experience of care for military hospitals is now available through the search function on Hospital Compare, along with data on VA Medical Centers. The DoD is also reporting several new measures for military hospitals on Hospital Compare, including: Percentage of patients receiving appropriate recommendation for follow-up screening colonoscopy (OP-29); Percentage of patients with history of polyps receiving follow-up colonoscopy in the appropriate time frame (OP-30); and Percentage of patients receiving appropriate radiation therapy for cancer that has spread to the bone (OP-33). The VA is reporting data on the percentage of healthcare workers vaccinated against influenza (IMM-3_OP-27).

HCAHPS Survey Changes - Coming October 2019

On November 5, 2018, NRC Health received notification from CMS regarding a very important update to the HCAHPS Survey scheduled for October 2019.

In response to recommendations from the President's Commission on Combating Drug Addiction and the Opioid Crisis, to comply with the requirements of the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment (SUPPORT) for Patients and Communities Act, and to avoid any potential unintended consequences, under the Hospital Inpatient Quality Reporting

(IQR) Program, CMS proposed a plan to remove the HCAHPS Survey's Communication About Pain items (questions 12, 13 and 14) on the HCAHPS survey. The recent release of the CY 2019 OPPS Final Rule requires the <u>pain items be removed from all surveys</u> <u>beginning with patients discharged on October 1, 2019 and forward</u>.

This change will affect all survey translations and all survey modes. The Communication About Pain measure will not be Publicly Reported. However, Preview Reports for the October 2019, January 2020, April 2020 and July 2020 Public Reporting periods will contain the hospital's score for the Communication About Pain measure along with the state and national averages. Preview Reports for the October 2020 Public Reporting period and forward will not contain the Communication About Pain measure.

NRC Health is diligently working to ensure a seamless update for October 1, 2019 discharges and forward. No action is required from you for this change to occur. We will continue to provide more information about the transition to the updated HCAHPS Survey in future correspondence.

CMS has announced an opportunity for the public to comment on their intention to revise the HCAHPS Survey by removing the three pain communication questions.

The deadline for submitting the CY 2020 APU exemption requests has been extended to 11:59 PM Eastern Time Monday, April 1, 2019.

ICH CAHPS

ICH CAHPS Star Ratings - Available

CMS began using star ratings to publicly report the ICH CAHPS quality measures published on the Dialysis Facility Compare (DFC) in October 2018. ICH CAHPS star ratings use a 5-star scale that makes it easier for consumers to compare ICH facilities. More stars mean better quality care. Star ratings are calculated for each of the three publicly reporting global ratings, each of the three composites, and an overall summary star. The table below provides an example to show how the summary star is calculated:

OAS CAHPS 2019 Web Mode Experiment

In response to feedback from hospitals and ambulatory surgery centers (ASC), CMS has started recruiting hospitals and ASCs to participate in a new mode experiment to assess the impact of adding Web-based survey administration. Data collection for the experiment is expected to start in the Spring of 2019 and will take place over 3 consecutive sample months.

Five modes of administration will be tested:

- 1. Mail-only
- 2. Telephone-only
- 3. Web- only
- 4. Web with mail follow-up to non-respondents
- 5. Web with telephone follow-up to non-respondents

CMS is aware that facilities invited to participate in the mode experiment may also be participating in voluntary national implementation. Therefore, CMS will allow facilities to participate in both the mode experiment and voluntary national implementation, if the patient volume supports both surveys.
