### 2021 & 2022 APU Compliance: Impact of COVID-19


Because Home Health CAHPS data submission was optional for Q4 2019 – Q2 2020 (October 2019 – June 2020), these quarters will be excluded from APU compliance determinations. CMS will include:

- ⇒ CY 2021: Q2 Q3 2019 (April September 2019)
- ⇒ CY 2022: Q3 2020 Q1 2021 (July 2020 March 2021)

#### Participation Exemption Requests Due March 31, 2021

Medicare-certified Home Health Agencies that served 59 or fewer unduplicated patients between April 1, 2019 and March 31, 2020 are eligible for exemption from participating in HHCAHPS. To qualify for exemption, HHAs must submit a Participation Exemption Request (PER). A new PER must be submitted each year to maintain exempt status. The deadline for submitting a CY 2022 APU PER is Tuesday, March 31, 2021. To access the PER form, please click <a href="here">here</a>.
