HCAHPS

Public Reporting Refresh

Data on <u>Care Compare</u> have been refreshed to reflect HCAHPS Survey scores from Q4 2021 – Q3 2022 (October 2021 – September 2022) and updated star ratings.

OAS CAHPS

Public Reporting Refresh

Data in the <u>Provider Data Catalog</u> have been refreshed to reflect OAS CAHPS Survey scores from Q1 2022 – Q4 2022 (January 2022 – December 2022). Results are available at the facility, state, and national levels.

HHCAHPS

Public Reporting Refresh

Data on <u>Care Compare</u> have been refreshed to reflect HHCAHPS Survey scores from Q1 2022 – Q4 2022 (January 2022 – December 2022) and updated Star Ratings. Data from previous reporting periods are available on the HHCAHPS website here.

Preview Reports

HHCAHPS Preview Reports including results from Q2 2022 – Q1 2023 (April 2022 – March 2023) are available on the <u>HHCAHPS website</u> until August 16, 2023. These data will be updated on <u>Care Compare</u> in October 2023.



CAHPS Hospice

Proposed Rule

CMS has issued a Proposed Rule that would make several changes involving CAHPS Hospice scoring:

→ The rule proposes to create a CAHPS Hospice Survey Index using adjusted bottom-box scores of the four CAHPS Hospice survey measures. Each hospice would receive a single score by taking a weighted sum of the scores for each CAHPS measure.

→ The rule proposes the CAHPS Hospice Survey Index be weighted twice that of the other scoring measures.

→ The rule proposes additional scoring changes designed to address missing HCAHPS scoring data where hospices with CAHPS data will be run through a version of the algorithm that considers the CAHPS Hospice Survey Index and hospices without CAHPS data will be scored using a version of the algorithm that does not consider CAHPS Hospice Survey Index scores. Scores will then be averaged by the total number of indicators used in order to make the two types of scores comparable.

CAHPS Hospice

Mode Experiment Results

The 2021 CAHPS Hospice mode experiment tested a new web-first mode of survey administration. Response rates are as follows:

Mode	Response Rate
Mail only	35.1%
Phone only	31.5%
Mixed mail-phone	45.3%
Mixed web-mail	39.7%*

*Per the <u>Final Rule</u>, "Response rates to web-mail mode were similar to mail only mode for those without email addresses (35.2 percent vs. 34.4 percent), but 13 percentage points higher for those with email addresses (49.6 percent vs. 36.7 percent)."

Although no changes to the CAHPS Hospice Survey have been adopted in the Final Rule, CMS will take results from the mode experiment into consideration in future rulemaking.



ICH CAHPS

Vendor Authorization Deadline

Facilities participating in the 2023 ICH CAHPS Fall Survey must have an authorized survey vendor by the August 31, 2023 deadline. Vendor authorization is only required if this is your organization's first time participating, you are changing to a new survey vendor, or Spring 2023 is listed as the ending survey period in your existing vendor authorization. Authorization instructions are available here.

Waiting Room FAQs

To encourage participation in the ICH CAHPS Survey, the ICH CAHPS Coordination Team published a set of frequently asked questions for dialysis facilities to display in waiting rooms. These materials have recently been updated to include Spanish and Chinese translations. It is recommended the FAQs be displayed throughout each fielding period. Final Rule

CMS has published the Skilled Nursing Facility (SNF) Prospective Payment System Final Rule. The CoreQ Short Stay Discharge Measure was not adopted for 2024 data collection or submission process.

CAHPS for MIPS

Physician Fee Schedule Proposed Rule

CMS has released the 2024 Physician Fee Schedule
Proposed Rule, which includes proposed changes to CAHPS
for MIPS. In order to promote equity, the rule proposes to
require administration of the CAHPS for MIPS Survey in
Spanish as well as English. It also recommends that
organizations consider administering the survey in the
additional available languages if it is appropriate for their
patient population.

Additionally, the rule proposes a 10-point reduction in the total available measure achievement points for MIPS clinicians and groups who register for the CAHPS for MIPS Survey but do not meet the minimum beneficiary sampling requirement. This would not apply to SSP ACOs who are required to field the survey.
