### OAS CAHPS

#### Updated Exempt CPT Codes

As CMS has continued to evaluate CPT codes that qualify patients for the OAS CAHPS Survey, they have identified additional CPT codes that are ineligible and should be excluded from OAS CAHPS surveying. The codes below have been added to the ineligible list.

Code	Description
25246	Injection of contrast into wrist prior to imaging procedure.
27093	Injection of contrast into the hip prior to imaging procedure.
31500	Introduction procedures on the larynx (inserting tube into trachea via mouth in emergency situation to maintain an open airway)
36005	Injection of contrast into the vein prior to imaging procedure.
36010	Cath placement, SVC, prior to imaging procedure.
36215	Selective cath placement, arterial, prior to imaging procedure.
36221	Diagnostic studies of cervicocerebral arteries (Imaging supervision and interpretation only)
36410	Venipuncture
37252	Intravascular Ultrasound procedure, done as an-add on procedure.
49424	Injection of contrast followed by imaging procedure.
51798	Measurement of urine by ultrasound

### OAS CAHPS

#### **Exemption For Size**

Hospital Outpatient Departments (HOPDs) who served fewer than 60 eligible patients in calendar year (CY) 2023 are exempt from fielding the OAS CAHPS Survey in CY 2024. If your organization qualifies for an exemption, you are required to submit a Participation Exemption Request form, which is available on the OAS CAHPS website <u>here</u>. Exemptions are valid for one year.

# **ICH CAHPS**


#### **Participation and Vendor Authorization**

In-center hemodialysis (ICH) facilities that served 30 or more survey-eligible patients in calendar year 2023 are required to field ICH CAHPS in spring and fall of 2024 to be compliant with CMS quality reporting requirements. ICH facilities that served fewer than 30 eligible patients can participate voluntarily. A comprehensive list of eligibility requirements is available <u>here</u>.

Facilities participating in the 2024 ICH CAHPS Spring Survey must authorize an approved survey vendor by the February 28, 2024 deadline. Vendor authorization can be completed when logged in to the <u>ICH CAHPS website</u> and is only required if:

- → Your organization is participating in ICH CAHPS for the first time,
- → Your organization is changing to a new survey vendor, or
- → Fall 2023 is listed as the ending survey period in your existing vendor authorization.
